OUR SPEAKERS



William Mezzullo, Head of JLEN AD, Foresight Group and REA Biogas Chair

William is the Chair of the Biogas Group and Head of AD for an Environmental Listed Fund called JLEN, managed by the Foresight Group. Prior to working in fund management, William was Head of Projects at Future Biogas from 2010 to 2016. William is passionate about renewable energy, having undertaken a PhD at the University of Bath in 2009 in bioenergy, prior to his move into industry.



Jane Lumb, Head of Non-Domestic RHI and Biomethane, BEIS

Jane leads the NDRHI and biomethane team at BEIS. This involves developing and delivering policies to reform the NDRHI, including recent announcements on Covid-mitigation measures alongside closure of the scheme; and developing the new replacement scheme for biomethane – the Green Gas Support Scheme. Before taking on this role, Jane has worked on a wide range of energy and sustainability issues across central and local government ranging from running operational energy and waste management teams, low carbon heat and renewable energy policies, to green financing and barriers to business engagement in carbon reduction initiatives.



Matt Hindle, Head of Gas, Energy Networks Association

Matt Hindle works with ENA's members on issues affecting the gas transmission and distribution networks, including the future role for gas in heat and transport and energy policy more widely. Prior to joining ENA, he spent six years working on green gas, energy policy and recycling issues for the Anaerobic Digestion and Biogas Association, ultimately as Head of Policy.



Simon Farris, Bioresources Strategy Manager, Severn Trent

Simon worked for Severn Trent in a variety of operational roles before joining the Renewable Energy team in 2011. Over the past 9 years he has developed a number of projects including the UK's first Commercial scale Sewage to Biomethane plant at Minworth, Birmingham. He is now the Strategy & Commercial lead for Bioresources, focused on the sustainable treatment of sewage sludge to produce energy and high quality biosolids. Severn Trent operates 27 Sewage AD sites, all of which operate CHP with 2 having additional Biomethane plants in operation and a further 2 Biomethane plants scheduled for completion in 2021.



Jesse Scharf, Green Gas Certification Scheme, Scheme Manager

Jesse manages the Green Gas Certification Scheme (GGCS), a biomethane registry generating Renewable Gas Guarantees of Origin (RGGOs) of for over 60 biomethane plants, representing over 3 TWh of annual capacity. Sales of RGGOs to consumers were over 2.5TWh in 2019 representing millions of pounds of value for biomethane plants and an increasing important income stream. The GGCS sits on the board of the European Renewable Gas Registry (ERGaR), working towards a multilateral trading system for RGGOs between European countries.



Richard Riley, Principal Consultant, Element Energy

Richard has worked in the transport team at Element Energy since completing his PhD in transport decarbonisation at the University of Leeds in 2016. Richard now leads Element Energy's work on the decarbonisation of heavy duty vehicles with extensive expertise in freight movements, freight decarbonisation options and decarbonisation pathways. Richard has also led a number of studies looking at pathways to meet net-zero targets, which has given him a detailed knowledge of the technical and behavioural changes needed over the next 30 years.



David Jones, Sustainable Transport Manager, Cadent Gas

David Jones is the Sustainable Transport Manager at Cadent Gas, formerly National Grid Gas Distribution, with responsibility for developing the company's low-carbon transport infrastructure strategy, an important part of the company's broader Future Role of Gas strategy. David is a Chartered Engineer with over 30 years of experience in the energy sector, specialising in climate change strategy, carbon management, and sustainable gas technologies including alternative fuelled vehicles. David has held senior positions in Shell, BG Group, Centrica and British Gas. More recently, David has created a portfolio of innovative projects which consider, amongst other important topics, optimisation of future network delivery of hydrogen for transport in the North West, and investigation of the impact of network purity on future hydrogen transport applications.



David Hurren, UK CEO, Air Liquide Biogas Solutions Europe

David Hurren graduated from Imperial College in Chemical Engineering. For most of his career he has worked in the Industrial Gas industry, apart from a 4 year spell in water & wastewater treatment. For the past 22 years he has worked for what is now Air Liquide UK, setting up and leading Air Liquide's Biomethane operations in the UK over the past 5 years. Air Liquide cover all parts of the Biomethane supply chain and in the UK, they have Gas to Grid Facilities, a virtual pipeline supplying Industrial heat users from the NTS, supply most of the Biomethane buses in the UK, and have a rapidly growing network of HGV refuelling facilities.
